Keeping Our Eyes on the Prize

Campaign Donations Still Needed with Chapter House Construction on Hold

In some way, shape, or form, we have all been impacted by COVID-19 this spring. Our undergraduate brothers are no exception to that, as they were forced to finish their spring courses online and figure out how to virtually strengthen our brotherhood. After initiating 20 new members in February, Gamma Chapter has been highly motivated to build on that momentum with recruitment this summer. They have stuck to their goals during these uncertain times, and we as alumni must do the same for Gamma Chapter.

Each member of the Gamma Chapter Alumni Association has kept their eyes on the prize this spring; that prize being a new home for Gamma Chapter. We are truly appreciative of the 185 brothers and friends of Gamma Chapter, listed on pages 4-5, who have brought Gamma Chapter closer to that prize by raising \$1,927,605 toward *Building the Future of Gamma Chapter: The Campaign for Alpha Sigma Chapter*. Their efforts were pivotal in securing a \$3.5 million loan commitment from Union Bank and Trust and retaining Hampton Construction.

TOUGH TIMES CALL FOR TOUGH, BUT SOUND DECISION

While we have made substantial progress, moving forward with this project during this pandemic would put Gamma Chapter at great risk. It is in the best interest of our brotherhood to put construction and the loan on hold. The thoughts of the Alumni Board of Directors, Alumni Building Board, and Chapter Executive Board were all taken into consideration, and everyone was in agreement that this was the safest decision. Several factors came into play to determine this new plan of action.

- First and foremost, the health and safety of our brothers
- An unpredictable economy
- UNL's enrollment
- Chapter size (membership retention and fall recruitment)

This fluid situation has the undivided attention of our alumni leadership. We are fortunate to have a wealth of knowledge from brothers with careers in a variety of fields, all of

whom deeply care about Gamma Chapter's future. Despite so many moving parts, we are committed to investing up to \$4.5 million on a new chapter house.

SHORT-TERM SOLUTION

For the time being, we are leasing the old ΑΔΠ chapter house. This was also considered as a permanent option, but it wasn't financially feasible because of potential renovation costs, minimal parking space, and being on the city campus.

LONG-TERM OPTIONS

Having a home on Holdrege Street is important in building upon Gamma Chapter's unparalleled legacy. Our original plan to renovate Gamma Chapter's home of nearly 50 years at 4001 Holdrege is still a possibility. We are also looking into purchasing and renovating the property at 3455 Holdrege. Here's a breakdown of both options.






SITE PLAN





some very special memories at this location since it was built in 1972. Our goal would be to shift from its current apartment-style setting to a suite-style setting, similar to the living experience you'll find at UNL's newest residence halls. On the flip side, selling the property at 4001 Holdrege could be a challenge if we choose to move to 3455 Holdrege. With its current layout, the facility still might need major changes for any prospective buyer to purchase it.

square feet and have 28 finished apartments apiece that can accommodate our membership of 65-70 brothers. The main level still needs to be finished, but would include 7,500 square feet for an entryway, study areas and lounge areas, chapter room, dining room, kitchen, and house director's apartment. There is a parking lot with 75 stalls. If the economy declines further, we could rent the apartments or rent it as a mixed-use facility.

Having been built in 2014, this building has the modern setting that college students are looking for. The second and third floors are 11,000




LEGACY ROOM




LEVEL 2 & 3 FLOOR PLAN

Fortieth and Holdredge became a home away from home for **Mike Jacobson '72, Γ266** as it has for many brothers of Gamma Chapter over the years.

As a member of the first pledge class to live in the "new" chapter house, he feels a personal responsibility to pay it forward for the next generation of brothers—so they can have the same life-changing experience he received at UNL, an experience that he has been reaping the rewards of ever since joining Alpha Gamma Sigma.



"The greatest impact that ΑΓΣ had on my career path was the camaraderie of the brothers, which gave me more confidence and allowed me to mature as a person," he said. "The leadership opportunities in the Greek system also allowed me to stretch my abilities."

Gamma Chapter saw considerable growth and improvement during the years Mike lived in the new house, and his leadership as chapter president made a difference then—just as his support of the capital campaign makes a difference now.

"I believe that the same type of growth and improvement will occur as we get the much-needed updates completed. Our primary competitors have already done significant upgrades to their house," he stated. "We cannot let anyone believe that we are inferior in any way to Alpha Gamma Rho and FarmHouse! Although the real value of a fraternity is determined by men within the chapter, you need a quality chapter house to help attract top talent."

The chapter house is also home to some of his favorite memories, including his brothers banding together and pushing him to become the Gamma Chapter president. "I was proud to serve in that role knowing the quality of people I was representing," he shared.

Another source of inspiration for supporting the capital campaign came from his pride in ΑΓΣ and his faith in the lasting friendships it affords. Some of those friendships have even extended into the professional realm for Mike and his Gamma brothers.

"I have always been proud to be an alumnus of Alpha Gamma Sigma Fraternity," he said. "My first roommate and pledge brother, **Daryl Wilton '72, Γ274** and I are both in banking. I do business with him whenever I can. The relationships we form in the Fraternity are for life!"

Mike understands that there is never a "perfect"

time to mark a large contribution to an organization such as ΑΓΣ for capital improvements, but he encourages alumni to get involved.

"We can all find many other priorities we need to fund, but we all need to understand that this project is very time sensitive and one that could have a long-term negative impact should we fail to get this effort fully funded," he stated. "If you need to spread your support over several years, then so do."

His support of *Building the Future of Gamma Chapter: The Campaign for Alpha Gamma Sigma*, is also undoubtedly driven by the future that Gamma provided him on a personal level.

"I met my wife, Julie, on an initial blind date during our second house party, and she later became part of the Little Sister program," Mike shared. "We were married between the semester break our senior year in 1975."

Mike and Julie have enjoyed almost 45 years of marriage, during which they endured the loss of their premature son, John, on their 10th wedding anniversary, and welcomed two adopted children, Mary and Josh, into their family as infants. Mary carried on the family tradition at UNL and went on to attend the GW Law School; she is now an attorney with the Bruning Law Group in Lincoln. Josh attended college in Minnesota and Texas as a competitive swimmer before returning to Lincoln to finish his degree at UNL; he lives in Minnesota where he's an insurance agent with Bankers Life Insurance Company. Thanks to his formative ΑΓΣ experience, Mike has enjoyed a successful career in the banking industry.
